Contributions to McCain-Palin Victory California ("Victory California") are not deductible as charitable contributions for federal income tax purposes. Victory California allocates contributions to the California Republican Party, the Republican National Committee ("RNC"), and McCain-Palin Compliance Fund ("Compliance Fund") in conformity with federal limits. Unless a contribution would exceed federal limits or a contributor designates otherwise, Victory California divides contributions as follows:

For Individuals—The first \$10,000 will go to the California Republican Party's federal account, the next \$28,500 will go to the RNC, the final \$2,300 will go to the Compliance Fund.

For Federal Multicandidate PACs—The first \$5,000 will go to the California Republican Party's federal account, the next \$15,000 will go to the RNC, the final \$5,000 will go to the Compliance Fund.

Contributions to the Compliance Fund will be used solely for legal and accounting services to ensure compliance with federal law and not for campaign activities. Compliance funds may defray a portion of broadcast advertising, national and state office "overhead," and computer/website expenses. Contributions to Victory California from corporations, labor unions, federal contractors, and foreign nationals without permanent residency status are prohibited. \*Federal law requires us to report the name, address, occupation, and employer of any contributor who gives more than \$200 in an election cycle (for Compliance Fund contributions) or more than \$200 in a calendar year (for RNC and state-party contributions).
